AN ACT

- 1 Amending Titles 18 (Crimes and Offenses) and 42 (Judiciary and
- Judicial Procedure) of the Pennsylvania Consolidated
- 3 Statutes, in definition of sexual offenses, providing for
- 4 unlawful dissemination of intimate image; and, in particular
- rights and immunities, providing for damages in actions for
- 6 unlawful dissemination of intimate image.
- 7 The General Assembly of the Commonwealth of Pennsylvania
- 8 hereby enacts as follows:
- 9 Section 1. Title 18 of the Pennsylvania Consolidated
- 10 Statutes is amended by adding a section to read:
- 11 § 3131. Unlawful dissemination of intimate image.
- 12 (a) Offense defined.--Except as provided in sections 5903
- 13 <u>(relating to obscene and other sexual material and</u>
- 14 performances), 6312 (relating to sexual abuse of children) and
- 15 <u>6321 (relating to transmission of sexually explicit images by</u>
- 16 minor), a person commits the offense of unlawful dissemination
- 17 of intimate image if, with intent to cause emotional distress to <--
- 18 the person depicted, the person disseminates a visual depiction

- 1 of another person HARASS, ANNOY OR ALARM A CURRENT OR FORMER
- 2 SEXUAL OR INTIMATE PARTNER, THE PERSON DISSEMINATES A VISUAL
- 3 DEPICTION OF THE CURRENT OR FORMER SEXUAL OR INTIMATE PARTNER in

- 4 <u>a state of nudity or engaged in sexual conduct.</u>
- 5 (b) Defense.--It is a defense to a prosecution under this
- 6 <u>section that the actor disseminated the visual depiction with</u>
- 7 the consent of the person depicted.
- 8 <u>(c) Grading.--A person who violates subsection (a) commits a_</u><--
- 9 <u>misdemeanor of the third degree and shall, upon conviction, be</u>
- 10 sentenced to pay a fine of \$1,000 or to imprisonment for not
- 11 more than six months, or both. Each violation shall constitute a
- 12 <u>separate offense</u>. AN OFFENSE UNDER SUBSECTION (A) SHALL BE:
- 13 (1) A MISDEMEANOR OF THE FIRST DEGREE, WHEN THE PERSON
- 14 <u>DEPICTED IS A MINOR.</u>
- 15 (2) A MISDEMEANOR OF THE SECOND DEGREE, WHEN THE PERSON
- 16 DEPICTED IS NOT A MINOR.
- 17 (d) Territorial applicability. -- A person may be convicted
- 18 under the provisions of this section if the victim or the
- 19 offender is located within this Commonwealth.
- 20 (e) Nonapplicability. -- Nothing in this section shall be
- 21 construed to apply to a law enforcement officer engaged in the
- 22 performance of the law enforcement officer's official duties.
- 23 <u>(f) Concurrent jurisdiction to prosecute.--In addition to</u>
- 24 the authority conferred upon the Attorney General by the act of
- 25 October 15, 1980 (P.L.950, No.164), known as the Commonwealth
- 26 Attorneys Act, the Attorney General shall have the authority to
- 27 investigate and to institute criminal proceedings for any
- 28 violation of this section or any series of violations involving
- 29 more than one county of this Commonwealth or another state. No
- 30 person charged with a violation of this section by the Attorney

- 1 General shall have standing to challenge the authority of the
- 2 Attorney General to investigate or prosecute the case, and, if a
- 3 <u>challenge is made, the challenge shall be dismissed, and no</u>
- 4 <u>relief shall be made available in the courts of this</u>
- 5 <u>Commonwealth to the person making the challenge.</u>
- 6 (g) Definitions. -- As used in this section, the following
- 7 words and phrases shall have the meanings given to them in this
- 8 <u>subsection unless the context clearly indicates otherwise:</u>
- 9 <u>"Emotional distress."</u> As defined in section 2709.1 (relating <--
- 10 to stalking).
- "Law enforcement officer." Any officer of the United States,
- 12 of the Commonwealth or political subdivision thereof, or of
- 13 another state or subdivision thereof, who is empowered to
- 14 conduct investigations of or to make arrests for offenses
- 15 enumerated in this title or an equivalent crime in another
- 16 jurisdiction, and any attorney authorized by law to prosecute or
- 17 participate in the prosecution of such offense.
- 18 "MINOR." AN INDIVIDUAL UNDER 18 YEARS OF AGE.
- 19 "Nudity." As defined in section 5903(e) (relating to obscene

- 20 and other sexual materials and performances).
- 21 "Sexual conduct." As defined in section 5903(e) (relating to
- 22 obscene and other sexual materials and performances).
- 23 "Visual depiction." As defined in section 6321 (relating to
- 24 transmission of sexually explicit images by minor).
- 25 Section 2. Title 42 is amended by adding a section to read:
- 26 § 8316.1. Damages in actions for unlawful dissemination of
- 27 <u>intimate image.</u>
- 28 (a) Cause of action established. -- A person may bring a civil
- 29 <u>cause of action based upon unlawful dissemination of intimate</u>
- 30 image, as defined in 18 Pa.C.S. § 3131 (relating to unlawful

- 1 dissemination of intimate image), in order to recover damages
- 2 for any loss or injury sustained as a result of the violation.
- 3 (b) Parties authorized to bring action. -- An action may be
- 4 brought by a natural person or a guardian of the natural person,
- 5 if the person is incompetent.
- 6 (c) Damages. -- A court of competent jurisdiction may award
- 7 damages as set forth in this subsection. In determining the
- 8 extent of injury, the court shall consider that dissemination of
- 9 an intimate image may cause long-term or permanent injury. The
- 10 court may award:
- 11 (1) Actual damages arising from the incident or \$500,
- 12 <u>whichever is greater. Damages include loss of money,</u>
- 13 <u>reputation or property, whether real or personal. The court</u>
- 14 may, in its discretion, award up to three times the actual
- damages sustained, but not less than \$500.
- 16 (2) Reasonable attorney fees and court costs.
- 17 (3) Additional relief the court deems necessary and
- 18 proper.
- 19 (d) Other remedies preserved. -- Nothing in this section shall
- 20 be construed to limit the ability of a person to receive
- 21 restitution under 18 Pa.C.S. § 1106 (relating to restitution for
- 22 <u>injuries to person or property</u>).
- 23 <u>(e) Nonapplicability.--The provisions of this section shall</u>
- 24 not be applicable to a law enforcement officer engaged in the
- 25 <u>law enforcement officer's official duties.</u>
- 26 (f) Definition.--As used in this section, the term "law"
- 27 <u>enforcement officer" means any officer of the United States, of</u>
- 28 the Commonwealth or political subdivision thereof, or of another
- 29 state or subdivision thereof, who is empowered to conduct
- 30 investigations of or to make arrests for offenses enumerated in

- 1 18 Pa.C.S. (relating to crimes and offenses), or an equivalent
- 2 crime in another jurisdiction, and any attorney authorized by
- 3 <u>law to prosecute or participate in the prosecution of such</u>
- 4 <u>offense.</u>
- 5 Section 3. This act shall take effect in 60 days.
