## A BILL FOR AN ACT

RELATING TO TRESPASS.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that visitor guide 2 websites and visitor quide publications may inadvertently invite 3 visitors to trespass on remote private property to experience an 4 attraction or activity. The representations made by these 5 websites and quide publications put visitors at potential risk 6 by describing attractions or activities without adequately 7 explaining the inherent dangers associated with them, that may 8 result in serious injury or death to the visitor. 9 The legislature further finds that a private landowner may **10** own or manage large tracts of land in natural areas that hikers and nature enthusiasts tend to seek out. If the landowner does 11 12 not have the personnel necessary to secure the area, even posted 13 "No Trespassing" signs may be unheeded. 14 The purpose of this Act is to establish a task force to

identify problem areas on the various islands and recommend
remedies to reduce the incidence of trespass over privately held
or public lands.
